PREFACE

In October, 1912, I was visiting my old native home in Lancaster County, Pa. In looking over the Steinmetz Cemetery at Schoeneck, Pa., I found the inscriptions on the various tombstones of our ancestors interred there many years ago, and I felt a great desire to have a genealogy of our ancestry, and made the remark to a niece of mine, "I wish some one would write a genealogy of the Shirk family." In reply she said, "Uncle Henry, no one could do that better than you."

Upon these encouraging words, having decided upon the undertaking, it was begun with a firm and confident determination to spare no effort or expense to effectually accomplish the great task of connecting the ten generations of the Shirk family, from 1665 to 1914.

My dear and respected kindred of the present and future generations, I have taken great pains in diligently gathering the data of the many different branches of the family tree of the Ulrich and Anna Swar Shirk descendants, in the belief and hope that my effort in compiling this book correctly will be appreciated and prove of interest to the present and future generations of the Shirk family.

THE SHIRK FAMILY HISTORY

Ulrich Shirk (I.) was born in January, 1665, in the Canton of Berne, Switzerland. He took up his abode later in Basle, where he married Helene Myer, a peasant girl of French and Swiss ancestry. This union was blessed with the following eight children: Ulrich (II.), Michael, John, Casper, Joseph, Peter, Martha, and Jeannette.

This family had grown to maturrity and ambition when the six sons became eager to reap the benefits open to all Europe to emigrate to America, which occurred in the year A. D. 1729, when the six brothers brought their aged parents and two sisters with them, and settled in about 1732 in Lancaster county, Pa., and there took out patents for more than 2,000 acres of land.

Ulrich Shirk (II.), the oldest of the six brothers, and also the ancestor of this genealogy, was born August 20, 1704, in the Canton of Basle, Switzer-/765 land; died 1736, aged 59 years, leaving a widow and ten children—three sons and seven daughters, viz.: Ulrich (III.), David, Michael, Elizabeth, Barbara, Anna, Kate, Magdalena, Sally, and Mariah. The widow's maiden name was Anna Swar, daughter of Jacob and Adaline Swar. She was born near "Hickorytown," which is now Lancaster, in the year A.

D. 1720; died 1810, arriving at the great age of 90 years, remaining a widow 47 years.

In Patent Book A. A., vol. 6, page 23, in the office of the surveyor general at Harrisburg, Pa., we find under the original patents issued by Thomas and Richard Penn, proprietories and governors in chief of the Province of Pennsylvania, a tract of land containing 357 acres in Cocalico township, Lancaster county, Pa., where this family resided with his parents until their death. They both were buried in the Conestoga cemetery in Conestoga Valley. These people brought with them from Europe thrift, honesty, frugality, economy, and the Mennonite faith of creed in their religion, which faith has been continued by a number of the Shirk family to this present time in Lancaster county, Pa., where we may see them attending the Lancaster market, wearing the familiar neat and unassuming plain garb of that church. Of those Shirks who emigrated to the west many have taken up with various other denominations, and as we find them all of an honest and pious disposition, we feel proud of them, and by their assistance will try to do them all justice in this narrative.

PATENT OF CONFIRMATION

Thomas Penn and Richard Penn, Esquires, the true and absolute proprietors and governors in chief the Province of Pennsylvania and Counties of New Castle and Sussex on Delaware.

To all unto whom these presents shall come; Greeting:

Whereas, in pursuance of a warrant under the seal of our Land Office, dated the seventh day of April, 1735, there was surveyed unto Ulrich Shirk a certain tract of land situate in Cocalico township, in the county of Lancaster;

Beginning at a post a corner of Peter Sherrick's land, thence extending by the same the eight courses and distances following, viz: North thirty degrees east, forty-two perches, to a post north thirty-four degrees east sixty perches, north ten degrees east forty-six perches to a post. North thirty-five degrees east seventy-four perches, to a marked elm tree, north six degrees east thirty perches to a marked Spanish oak, north three degrees east one hundred and thirty perches to a post, north five degrees east seventy perches to a marked black oak and north forty degrees, east two hundred and fourteen perches to a marked black oak, thence by vacant land west by south ninety-four

perches to a marked white oak, and south-west by west one hundred and twenty perches to a post, thence by land of Christian Settlers and vacant land south, south-west four hundred and ninety-four perches to a marked oak, thence by vacant land east, south-east one hundred and thirty-four perches to the place of beginning. Containing three hundred and fifty-seven acres, and allowance of six acres per cent. for roads and highways as in and by the said warrant and survey remaining in the surveyor general's office and from thence certified into our secretary's office appears, and whereas the said Ulrich Shirk in and by his last will and testament bearing date the second day of September, 1736, 1763 did order and direct that his executors therein named, to-wit: Abraham Brubaker, John Shirk and Benedict Bucher, should out of his personal estate clear his the said testator's land in the land office, and that a patent for the said land should be made to them his said executors in trust for his three sons, namely: Ulrich Shirk, David Shirk and Michael Shirk, and their heirs and assigns to be divided among them in three equal parts according to the number of acres in manner therein directed charged as therein expressed and reserving to his said testator's widow her residence thereon during her widhood and the said executors and survivors to make lawful deeds to each of the said three sons for their shares accordingly as in and by the said will duly proved and remaining in the register's office at Lancaster more fully appears, and whereas the said

executors have accordingly out of the said testator's personal eastate paid off our purchase money, interest and arrears of quit rent for the said tract, and have now humbly besought us to grant them our Patent Confirmation for the same in trust, as aforesaid, now know ye, that in consideration of the premises and of the sum of one hundred and eightysix pounds four shilling and eleven pence lawful money of Pennsylvania, to us paid by the said Abraham Brubaker, John Shirk and Benedict Bucher (The receipt whereof we hereby acknowledge and thereof do acquit and forever discharge the said Abraham Brubaker, John Shirk and Benedict Bucher their heirs and assigns by these presents) and of the yearly quit rent hereafter mentioned and reserved.

We have given granted and released and confirmed, and by these presents for us our heirs and successors do give grant release and confirm unto the said Abraham Brubaker, John Shirk and Benedict Bucher their heirs and assigns all the said tract of three hundred fifty-seven acres of land herein before described as the same are now set forth bounded and located as aforesaid with all mines numerals quarries, meadows marshes savanahs swamps cripples woods underwood, timber and trees, ways waters watercourses liberties profits commodities advantages heritaments and appurtenances whatever thereunto belonging or in anywise appertaining and lying within the bounds and limits aforesaid. Three full and clear fifth parts of all

Royal Mines free from all deduction and reprisals for digging and refining the same and also one-fifth part of the ore of all other mines delivered at the pits. Mouth only accepted are hereby reserved, and also free leave right and liberty, to and for the said Abraham Brubaker, John Shirk and Benedict Bucher their heirs and assigns to hawk, hunt fish and fowl in and upon the hereby granted land and premises or any part thereof, to have and to hold the said three hundred and fifty-seven acre tract of land and premises hereby granted with appurtenances unto the said Abraham Brubaker, John Shirk and Benedict Bucher their heirs and assigns, In Trust heirs nevertheless to and for the use of the widow and all the children of the Testator in manner in the said Will, limited ordered directed and appointed to be holden be fully paid and discharged.

Lieutenant Governor of said Province who by virtue of certain powers and authorities to him for this purpose interalia granted by the said proprietories hath hereunto set his hand and caused the great seal of the said Province to be hereunto affixed at Philadelphia this fifteenth day of June in the Year of our Lord one thousand seven hundred and sixty-four. The fourth year of the reign of King George the third over Great Britain, Etc.

And the fourty-sixth year of the said Proprie-

tories Government.

Ulrich Shirk's Will and Last Testament

Sept. 2nd, 1763.

In the name of God Amen:

I, Ulrich Shirk, being weak in body but sound in mind and memory, thanks be unto God. Considering the mortality of my body, do make herewith my last will and testament in manner as followeth:

I ordain that my beloved wife as long as she continues a widow, shall have the direction of my family in the same manner as I have now. My children shall be to her command until their age, and my daughters shall not have their portion until my youngest son is come to his age, but then my wife shall not charge any of my children for their education and shall further: What gain she makes on said land in that time be bound to divide the same between her and them of my children which

did assist her in maintaining the family she taking one half and said children the other.

Further I ordain that when my youngest son is come to his age: My personal Estate shall be divided between all my heirs in equal shares and none of my heirs shall have any prerogative before the others and my wife giving good security for her remaining a widow during her natural life shall besides her due out of said estate have a portion, as any of my other heirs, and shall further have instead of her third part of the income of my land, from each of my sons a year thereafter he hath taken possession of his share of land and that during her natural life, the interest lawful from sixty-seven pounds money of Pennsylvania which principal sum arising from my land shall not be divided among my heirs until after my wife's death.—

All my land shall be cleared in the land office out of my personal estate and a Patentt shall be drawn upon my three Executors hereafter mentioned as in trust for the use of my three sons, their heirs and assigns and when my eldest son has come to his age, then by four arbiters chosen from the congregation of the Mennonites indifferently, by my sons or their guardians. My land shall be divided into three equal parts according to the number of acres, and each third part shall be valued by them and my wife shall be free to give him of my sons which did deserve the best her favor that part of my land whereon the buildings are but she shall have her residence there during all the time of her

widowhood, and if my wife shall die before that time my land shall be divided by lots.—

Each of my sons having obtained his age, shall when he giveth sufficient security for the money allotted to him to be paid by him for his said share take possession of his said share of land, and then one of my Executors by name John Shirk or in case he should die before that time any of the two others. Or the two others shall sign a good lawfull Deed to the said my sons their heirs and assigns and his Deed shall be acknowledged as done by myself. I further ordain that any of my sons so taking possession of his share of land, shall pay every immediately following year after he has taken possession of said land of that sum allotted to be paid by him for said share the sum of thirty pounds, but he that gets the buildings in his possession shall pay forty pounds until each has entirely satisfied for his due, two hundred pounds excepted, being laid up on interest for my wife's use as aforesaid.-

To my daughter Anna I bequeathe a legacy of twenty pounds money aforesaid, to be paid unto her at first opportunity.

Further I ordain that my beloved wife marrying again, shall have no more of estate but her third according to law, and I further ordain that my Executors shall have full power to redress anything done or to be done on said my plantation tending to her damage ruin or destruction.—

Finally I ordain and constitute Executors of this my last will and testament, my three loving friends

Abraham Brubaker, John Shirk and Benedict Bucher.—

In witness whereof I have to these presents set my hand and seal this second day of September, 1763.

DESCENDANTS OF ULRICH SHIRK III.

Ulrich Shirk (III.), the eldest of Ulrich (II.) and Anna (Swar) Shirk, was born near Schoeneck, Cocalico township, Lancaster county, Pa., May 16, 1751; died May 14, 1842, aged 91 years. He was married to Mariah Eberly, who was born December 20, 1759, died June 26, 1831.

To their union were born twelve children—seven sons and five daughters, viz.: Mariah, born 1777, she never married, died 1861, aged 84 years; John, Anna, David, Samuel, Catharine, Elizabeth, Ulrich (a mute), Jacob, Joseph, Peter, and Sarah. Some of this family, as will be stated, became very old.

David Shirk, next in line of birth to Ulrich (II.) and Anna (Swar Shirk, was born 1753, and married Barbara Erb. They moved south, where all traces of their descendants are lost in obscurity.

Michael Shirk, a son of Ulrich (II.) and Anna (Swar) Shirk, born May 26, 1758, died April 4, 1827. His descendants are given later of this family.

Elizabeth Shirk, daughter of Ulrich (II.) and Anna (Swar) Shirk, married John Funck; Barbara married John Yeagy; Anna married Jacob Frantz; Kate married Joseph Baer; Magdalena married David Gockley; Sally married Adam Frantz; and Mariah married George Frantz. Descendants of those marriages are quite numerous all over the United States, but not being of the Shirk name, were not in their lineage easily traced to our present generation.

We will now take up and continue to the present generation the descendants of Ulrich (III.) and Mariah Eberley Shirk as follows:

John Shirk, the first son and second child of Ulrich and Mariah (Eberley) Shirk, was born on the farm owned by his father near Schoeneck, Pa., in the year A. D. 1779. John was the first one to die out of this family, after being twice married and leaving a wife and nine children, his first wife being the mother of these children. Her maiden name was Elizabeth Hacker. After she died, he married Mrs. Susan (Wieland) Bentz; no issue of this last union. The family of the first marriage consisted of the following: Samuel, Lydia, Emanuel, John, Jacob, Elias, Mary, Daniel and Elizabeth. John, the father of this family, died in 1837. Susan, his second wife, outlived him and again married John Shirk, a cousin of her former husband, better known as "Indian Town" John, of whom we will again write under the Michael Shirk branch of this book.

We will next take up John and Elizabeth (Hacker) Shirk's eldest son's descendents.

Samuel Shirk was born in Lancaster county, Pa., February 10, 1802, where he also was reared on his father's farm, when he united in marriage to Miss Susana Baker, she being born and reared in the same county. Her birth occurred August 12, 1804. To this union were born eleven children—seven sons and four daughters: Levi B., Susan, Samuel B., Jacob, Martin, John, Amanda, Elias, and Lydia; all living to maturity, except Jacob, who died after their removal to Ohio, at the age of fifteen years.

In the spring of 1845 he moved from Lancaster county, Pa., to Stark county, Ohio. Having sold his farm the previous autumn in Pennsylvania, and during the same winter went to Ohio and bought of George Lininger one of the finest and best located as well as most productive farms in Stark county, being pleasantly located nearly midway between Louisville and Canton, the place being the well-known "Bull Barn" farm. This was a large bank barn facing east, and on the north gable adjoining the public road was the picture of two life-size bulls in the attitude of an approaching combat.

With several of his neighbors and friends of his former home in Lancaster county, Pa., he started to this beautiful home in Stark county, Ohio, with their families and part of their household goods loaded on large covered wagons of the colonial style (railroads not being in commission then west of the Allegheny mountains). This move required about twenty or thirty days, connected with many priva-

tions and hardships, crossing the mountains to the then far west, which at this present age would be considered only a trifle. They took up their abode on this 160 acre farm of rich and fertile soil, and prospered. He soon acquired two more farms, when death invaded this happy and prospercus family. First, by taking away their son, Jacob, in 1849, aged fifteen years. November 26, 1853, the mother of this family was called to her eternal home, leaving the bereaved father alone to care for his family, when in a few years he married his second wife, Catharine Klingaman of Stark county, Ohio. To this union was born only one child. Lizzie Shirk was born Nov. 18. 1857. She married in Canton, O., Constand Hena, a native of Baden, Germany, born May 22, 1855. To them was born an only child, Warren W., December 15, 1875, died May 16, 1894.

Levi B. Shirk, the first born of Samuel and Susanna (Baker) Shirk was born in West Cocalico township, Lancaster county, Pa., September 20, 1824, united in marriage to Rachael Lichtenwalter, of Osnaburg township, Stark county, born April 24, 1833, died January 13, 1891, aged 57 years. Levi B. died on his farm near Osnaburg, Ohio, November 12, 1855, aged 34 years. Levi B. and Rachael were the parents of six children: Jacob L., born May 10, 1850; Benjamin F., February 6, 1852; Malinda, October 8, 1853; Susan August 31, 1855; Harvey L., December 8, 1853; Levi, May 28, 1858.

Jacob L. Shirk, the first born of Levi and Rach-

ael Shirk's children, married at Melmore, Seneca Co., Ohio, Oct. 12, 1874 to Miss Katherine Shirk a daughter of Elias and Polly (Eberly) Shirk of "Broken Sword," Crawford Co., Ohio. To their union were born seven children, Lula A., Dec. 8, 1879, Edna M., Nov. 8, 1883, died July 21, 1904. Percy J., born Feb. 16, 1888, Flossie A., Jan. 1, 1890, died March 15, 1900, Herbert L. born Jan. 17, 1893.

Lula A. married Rev. Walter T. Hinzman of Cleveland Ohio, July 3, 1900. Born to this union Alvin T. at Cleveland, Ohio, March 16, 1902. Wade MC. at Salem, Mich., Feb. 28, 1906, Paul R., May 23, 1913.

Norman Shirk married Miss Elizabeth Bartels in Cleveland Ohio, Oct. 26, 1907. Born to them Gladys E. in Cleveland, Ohio, Dec. 13, 1907.

Lotta M. Shirk married Ora F. Sponseller, Aug. 27, 1902. Mr. Sponseller was born in Seneca Co., Ohio, May 7, 1879. To their marriage were born Chester J. in Crawford Co., Ohio, May 27, 1903. Charles Harold born same place Sept. 17, 1905, Russel Dale born same place Oct. 29, 1907, Helen Cordelia born March 17, 1910, William Frederick born Feb. 14, 1912.

Percy J. Shirk married, one son born, Leroy, Aug. 13, 1913.

Benjamin F. Shirk, second son of Levi B. and Rachael Shirk, married Miss Henrietta J. Lotz, daughter of Adam and Catherine Lotz, who was born in Carroll Co., Ohio, April 8, 1857. Married Nov. 20, 1879, by J. J. Leberman, pastor of Reformed Church, Louisville, Ohio. To their union were born five children, Eva May, born Osnaburg Twp., Stark Co., Ohio, Dec. 22, 1880, Charles L. born Sept. 7, 1882, Maude L. born Dec. 4, 1884. Rachel C. born June 26, 1888, Canton Ohio, died May 4, 1902. Adam Franklin, born Canton, Ohio, May 20, 1893.

Eva May Shirk married Charles C. Feebles. He was born Berea Ohio, June 7, 1878. To them are born two children—William Franklin, born in Canton, Ohio, July 9, 1902, Elizabeth Lucretia, born Jan. 10, 1907, Canton, Ohio. B. Frank Shirk, the father of those descendants is engaged in the Meat Market trade in Canton Ohio, for a number of years.

Malinda, daughter of Levi B., and Rachel Shirk, married Daniel Kagey, son of Abraham and Miss (Snyder) Kagey, of Stark Co. Ohio, who was born Feb. 14th, 1847, died March 2nd 1895, aged 48 years, 16 days. Married Jan. 29, 1872, by Peter Herbruck, Canton, Ohio. This union was blessed with five children: Clarence Calvin was born in Louisville, Ohio, Feb. 3, 1873. Mabel Gertrude, was born in Nimashillin Twp., Stark Co., Ohio, March 3, 1875. Franklin Elmer, born in Nimashillin Twp., Stark Co., Ohio, Jan. 22, 1877, died Sept. 6, 1878, aged I year, 7 months and 15 days. Richard Garfield, born Oct. 17, 1885, Leroy Harrison, born Osnaburg Twp., Stark Co., Ohio, May 3, 1880. Died Oct. 20, 1912, aged 24 years, five months and 17 days.

Mabel Gertrude Kagey, daughter of Daniel and Malinda (Shirk) Kagey, married Alison B. Horst, son of Martin and Mrs. Horst. He was born Canton Twp., Stark Co., Ohio, Sept. 23, 1873. To them were born three children, Lloyd M., born Canton Twp., Stark Co., Ohio, April 20th, 1897. Agnes B., born Aug., 26th, 1898, Paul R., born Sept., 23rd, 1900.

Clarence Calvin Kagey, son of Malinda and Daniel Kagey, married Miss Ada M. Coder, born Osnaburg Twp., Stark Co., Ohio, Aug. 18th, 1875, were married in Louisville, Ohio, Nov. 26th, 1895, by Rev. J. Leberman.

To them were born three children, William Leland, born Osnaburg Twp., Stark Co., Aug. 25, 1897, Beulah M. Kagey, born Aug. 4, 1898, died July 27, 1899. Annetta Arline Kagey, born Jan. 9th, 1905.

Susan Shirk, daughter of Levi and Rachel Shirk married June 7th, 1875 to Joseph Warren Rohrer. He was born Aug. 24th, 1848. Their union was blessed with nine children: Edith Pelle, born March 22nd, 1874, Roswell M. born July 13th, 1875. Elizabeth, born Sept. 1st, 1877. Rachael Genette, born Feb. 7th, 1880. Joseph Warren. Jr., born July 4, 1882. Benjamin Franklin, born Feb. 24th, 1885. Susan Lewenna, born April 30th, 1887, John Alvin, born Sept. 22nd, 1889. Estella Hazel, born March 24th, 1893.

Joseph Warren Rohrer, Jr., married Sept. 30th, 1908 to Rose L. Rubin, born Nov. 17, 1881.

Their children born to them are: Pauline Edith Rohrer, born Aug. 13, 1909. Josephine Louisa Rohrer, born June 13, 1911.

Roswell M. Rohrer married Oct. 7, 1908 to Alta Leone Watson, born July 29, 1886, Benjamin Franklin Rohrer married Nov. 20, 1912, to Lula May Bayard, born July 1, 1887. Edith Belle Rohrer married June 5, 1901, to Wm. R. Tilton, born March 2, 1859. Their children, Daniel Monroe Tilton, born Sept. 26, 1905, William Harold Tilton, born Apr. 26, 1908, Rachael Genette Rohrer, married June 3, 1903, to Edward Arnold Rubin, born March 28, 1879. Their children are: Estella Rachael Rubin, born May 13, 1904, Russell Rohrer Rubin, born Oct. 23, 1906. Hazel Mayetta Rubin, born April 16, 1909, Joseph Edward Rubin, born March 11, 1912.

Elizabeth Rohrer, married Oct. 6, 1897, to Alban Koons Gibbs, born Sept. 23, 1871. Children of same, Donald Ralph Gibbs, born July 8, 1898. Edith Evangeline, born May 23, 1900. Helen Genette, born June 7th, 1901. Jesse Marcella born Jan. 5, 1909, Wade Allan, Oct. 15, 1912.

Harvey L. Shirk, the 5th child and third son of Levi B. and Rachael Shirk, married Miss Cora H. Criswell, daughter of Gregory and Sarah Criswell, born in Osnaburg Twp., Stark Co., Ohio, Feb. 8, 1860. To them were born four sons: Ray Gregory was born in Louisville, Stark Co., Ohio, June 11,

1890. Now a student at Yale College, New Haven, Conn. (1914). Donald Criswell was born Nov. 28, 1892. A natural musician, an expert on the piano. Wade Tecumseh, born Feb. 26, 1895. Bernard Harvey was born May 25, 1897. The two youngest are both attending High School at Louisville, Ohio.

Harvey L. Shirk is the owner of a fine residence where he resides near the corporation of Louisville, on the Canton and Louisville road where he raised his family to usefulness and honor. Mr. Shirk is interested in selling high grade rubber goods, physicians supplies and scientific surgical specialties. In his younger days had been teaching school for many years both in his native state and in the state of Indiana, and is generally known for his sterling and worth of character and integrity.

Levi Shirk, the sixth child and fourth son of Levi B. and Rachael Shirk, married Miss Laura A. Kuhlman, daughter of Solomon and Leah (Keller) Kuhlman, born near Canton, Ohio, Sept. 7, 1857, married in Louisville, Stark Co. Ohio, by Rev. Josiah Keim, May 29, 1880. Anna Shirk, a daughter of Ulrich and Maria Eberly Shirk, was born on her father's farm near Schoeneck, Lancaster Co., Pa., dates not known, united in marriage to Rev. Abraham Brubaker, a minister in his time of the old Mennonites, and also a native of Lancaster Co., Pa., where, after marriage, took up their abode during their life time. To this union was born one son, Jacob Brubaker, who was married, and father of three children, one son and two daughters, of whom no information was to be obtained by writing, and the little known of the family is confined to a personal knowledge of the writer of this book, which is very meagre and limited to this family. It is almost certain that there are in existence a number of the Anna Shirk Brubaker descendants which cannot be mentioned here on account of failure of response to the writer's request.

David Shirk, second son and third child in line of birth to Ulrich and Mariah Eberly Shirk, was born on the farm of his father near Schoeneck, Pa., March 5, 1783, died March 6, 1878, aged 95 years. Anna (Kurtz) Shirk, his wife, was born July 26, 1783, died May 26, 1848, aged 65 years. After their marriage they took up their abode on a fine farm near Brownstown, Lancaster Co., Pa., where to them were born the following children: John, Ulrich, Samuel and David, and three daughters: Mrs. Hershberger and three were married to three Kurtz's.

John married Miss Kimmel. To them was born an only child, Elizabeth, who married Christian Brubaker. To these were born two sons; both studied and practiced medicine, one of them being the renowned specialist, Dr. A. S. Brubaker, of Indianapolis, Ind., now deceased.

Ulrich married a Miss Kurtz. To them was born John Shirk, an only child, who married a daughter of Dr. Wiest, of Schoeneck, Pa. They took up their abode on his father's farm, near the Conestoga, at Oregon, Lancaster Co., Pa.

Samuel married Miss Oberholtzer. To them was born an only child, David O., who married Miss Kurtz, a lady of great wealth, David O. becoming through this marriage one of the wealthiest Shirks in Lancaster Co., Pa., owning a number of the finest farms in the county. His wife dying soon after marriage, when David for his second wife married Miss Kohr, of Lancaster, a daughter of Rev. John Kohr. To this union were born Dr. John R. Shirk, of East Chestnut St., Lancaster, who is the well known Mennonite physician of that city. He is married to his second wife, a Miss Weaver, a very estimable lady of the same denomination, both wearing the plain garb of the Mennonite church.

Note.—The genealogy of the elder David Shirk could not be completed to date, by failure of response by request made by the author of this book to some of the members of this branch, which is to be very much regretted by all concerned.

Samuel Shirk, next in line of birth of Ulrich and Maria (Eberly) Shirk, was born near Schoeneck, Lancaster Co., Pa., Aug. 29, 1785. He married Miss Susan Mohler in 1813. She was born in 1789. To this union were born six children—four sons and two daughters: Isaac M., at the Shirk cross roads, West Cocalico twp., Lancaster Co., Pa., Dec. 19, 1814; Jacob M., born same place in 1816; Mary, born same place in 1818; Sallie, born same place in 1821; Samuel, born same place, June 8, 1824; Reuben, born same place, in 1826.

The wife and mother died at this home near Schoeneck in 1826, aged 35 years. Samuel, after having the care and responsibility of this family for two years, married his second wife in 1828. His second wife was Miss Mary Yocom, daughter of Daniel and Catherine (Fox) Yocom. They are of Irish ancestry. Mary Yocom was born in Catawissa, Pa., Nov. 18, 1795. To this union were born six children—four sons and two daughters: Levi, Daniel, Henry, Eliza, Rudolph and Catharine. The two first named were born at Shirk Cross Roads. Samuel and Mary Shirk moved from Lancaster Co. to near Reading, Berks Co., in 1832, where they resided three years, when in 1835 they moved to near Hinkletown, Lancaster Co., Pa. Four years later they moved to Mt. Joy, Lancaster Co., Pa., where children of the second wife were reared. The issue of the twelve children all attained their majority, and most of them lived to be quite old.

Samuel Shirk, the father of this large family, departed this life March 30, 1864, aged 78 years, 7

months. Mary, his wife, died March, 1873, aged 77 years, 6 months. Their remains are resting in the Keller cemetery, Springville, Lancaster Co., Pa.

Isaac M. Shirk, the first child of Samuel and Susan (Mohler) Shirk, married Miss Susan Rock, also a native of Lancaster Co., Pa., born March 13, 1818. To this marriage were born three children—two sons and one daughter: Harrison Rock, Elizabeth and Samuel.

Harrison Rock, born near Mount Joy, Lancaster Co., Pa., in 1846, where he also received his education and in Harrisburg, Pa., studied law, and later taught school a number of years. He was united in marriage to Louisa Hoffer, a native of Juniatta Co., Pa. To them was born an only daughter, Agnes, who married Mr. Kreider, and for her second husband, is married to Albert Spofferd. They are now living in Tacoma, Wash. H. Rock Shirk has been serving his county as auditor two terms, is now residing at Harrisburg, Pa.

Elizabeth Shirk, the second child in line of birth, and only daughter of Isaac M. and Susan Rock Shirk, was born near Mount Joy, Lancaster Co., Pa., Oct. 4, 1850, where she received her education, which enabled her to teach school while single. She united in marriage to John D. Simons, who was born at Kissell Hill, Lancaster Co., Pa., May 11, 1838, died July 7, 1904, aged 66 years. To this union were born five sons, all living: Christian S., May 14, 1877; Isaac S., May 26, 1879; John S., Nov. 21, 1883; William S., July 5, 1887; Samuel S., Nov. 26, 1889.

Christian S. Simons is married to Emma Bollock, she being born March 17, 1874. They are the parents of five sons living, and one daughter deceased. Their residence is Mount Joy, Pa.

Isaac S. is a student in the medical course at the University of Pennsylvania; John, a student at Columbia University; Samuel S., teaching at Marietta High School and preparing himself for college.

William S. united in marriage to Miss Anna Ruth Shrite, of Leamon Place, Pa., on Aug. 12, 1913. His wife, Anna Ruth, was born Dec. 31, 1893. Mr. Simons is teaching in the Paradise high school, Leamon Place, Pa. These young men are all of a studious nature, and by their mother's judicious method in rearing and educating them, will enable all to become men of usefulness and honor.

Samuel R. Shirk, the youngest of Isaac and Susan Rock Shirk's children, was born at Mount Joy, Pa., 1855, is by occupation a painter and decorator, which vocation he has followed for many years.

Mr. Shirk is a man of quiet and unassuming nature and good moral habits, has never married, and has his home with his sister at Marietta, Pa., Mrs. John Simons. Isaac M. Shirk, the father of the foregoing family, fell from a wagon and died from the effects the next day, Feb. 14, 1885, aged 70 years, 1 month and 25 days.

Susana (Rock) Shirk died Sept. 21, 1898, aged 80 years, 6 months and 8 days. Both are buried at the Mount Joy cemetery, where also their son-in-law, John Simons, is buried.

Jacob M. Shirk, second son of Samuel and Susan Shirk, born in West Cocalico twp., in 1816. learned the saddle and harness trade, followed his vocation at Reinhold Station, Pa., the balance of his life. He married Miss Susan Kline, a daughter of Mr. and Mrs. Michael Kline, Esq., of West Cocalico, Lancaster Co., Pa. She died a few years after marriage, when he married Miss Polly Buffenmyer, who was born in 1832. To this union were born two children, a son dying in infancy, and a daughter, Emaline, born 1851. She married James K. Hartman, proprietor of the hosiery mill in Gouglersville, Berks Co., Po. To this union were born the following named children: Calvin; Alice, wife of James Matz, residing in Gouglerville; Robert, in Edison, Pa.; Amy, wife of Chester Wentzel, of Harrisburg, Pa.; Elmer, married, and his father and grandmother are living with them. Emaline, the mother of the above children, died Oct. 8, 1911, aged 60 years, 3 months, 10 days. Interment in Wyomissing cemetery, Pa.

Jacob M. Shirk died in 1897, aged 80 years, 2 months, 7 days. His remains are buried in the Denver, Pa., cemetery.

Mary Shirk, daughter of Samuel and Susan Mohler Shirk, was born in 1818. Married George Swee-

ley, a native of Lancaster Co., Pa., born May 3, 1815, he being a blacksmith by trade, following that vocation first in Mount Joy, Lancaster Co., Pa., from there moved to Bellefonte, Center Co., Pa., from there to Naperville, Ill., from there to Waterloo, Ia., from there to Norton, Norton Co., Kans., where he died at the advanced age of 84 years, on April 5, 1899. His wife died Aug. 9, 1903, aged 84 years.

To their union were born six children—three sons and three daughters: Henry, the first born, in Mount Joy, Pa., died in infancy; Malinda, also born in Mount Joy; Elizabeth and Emma being born in Bellefonte, Pa. Harrison and Samuel were born in Naperville, Ill. Malinda Sweeley married Mr. Motter. Two children were born to them: Mrs. Messinger and Edna are at home their residence being Aurora, Ill.

Lizzie, or Elizabeth Sweeley, married Edward Stevens. He died in 1889. Lizzie died in Cheyenne, Wyo., where their children are living.

Harrison Sweeley left home many years ago, whence all traces of his life are lost in obscurity.

Emma Sweeley, with her parents, moved to Norton Co., Kans., where she married Clark Heath, a native of that state. To them were born an only daughter Mamie. In 1890 she died at the age of 20 years. Mr. Heath, also dying, leaves Emma a widow on a farm alone, in Norton Co., Kans.

Samuel Sweeley, the youngest of the family, came to Norton Co., Kans., with his parents in 1879. He had remained with his aged parents while they lived, caring for his widowed mother. Samuel M. Shirk, next in line of birth of Samuel and Susan Mohler Shirk, learned the harness trade, and worked at the vocation the most part of his life. In 1848 he married Miss Catherine Klingaman, daughter of Michael and Polly Fetter Klingaman of near Louisville, Ohio. To their union were born five children: Jacob K., Henry, Samuel, Daniel, and Mary. Henry died in infancy. Jacob was born near Louisville, Ohio, in 1852, married Miss Jennie Curtie, of French descent. To them were born three children, one boy dying in infancy; and two girls, Ella and Amanda, both married, and living in Cleveland, O. Jacob K., their father died Oct. 1881, aged 29 years, buried at Bremen, Ind.

Samuel Shirk, a son of Samuel M. and Catharine Klingaman Shirk, was born near Louisville, O., June 2, 1859, came with his parents in 1877 to La-Paz, Ind., where he also received a liberal education in the common schools of those days. He united in marriage with Anna Pierce, of Marshall Co., Ind., Feb. 14, 1883. Anna, his wife, was born Nov. 26, 1864. To them were born seven children—six daughters and one son: Ellen A., born July 19, 1884, died Sept. 19, 1884; Grace M., born Feb. 9, 1886, married Jesse G. Boyle June 30, 1908; Catharine M., born July 4, 1888, married George L. Paul

April 21, 1908; Bertha F., born July 8, 1891, married Elton R. Boyle Jan. 27, 1910; S. Frank, born Nov. 25, 1895; M. Fern, born Oct. 30, 1897. The two last, at this writing, (1913) are attending high school, 10th grade, at Galien, Mich., where the parents are residing.

Samuel's occupation is railroading on the Michigan Central. He has given all his children an endowment of a good education. All are fully capable of teaching school, which has been the occupation of several of the girls.

Daniel Shirk, son of Samuel M. and Catharine Shirk, was born in 1866. He married and they are the parents to their union of one daughter. They reside on a farm near Silver Lake, Wabash Co., Ind.

Mary Shirk, only daughter of Samuel and Catharine Shirk, was born near Louisville, O., 1870, is unmarried, had been caring for her mother until death. Her mother died at North Manchester, Ind., June, 1913, aged 82 years, her husband, Samuel M. Shirk, preceding her in death nine years, aged 78 years, 9 months.

Reuben Shirk, the last child born to Samuel and Susan Mohler Shirk was born near Schoeneck, Lancaster Co., Pa. Learned the shoe making trade of Conrad Gast, Lancaster City and continued this vocation during the remaining days of his life.

In 1847 was united with Mary Swilkey daughter

of Mr. and Mrs. John Swilkey of Lancaster, Pa. To them were born three children, two of them dying in infancy and Reuben, Jr., born July 14, 1851. The father died when his son Reuben was three months old, on Oct. 1851, aged 25 years. Mary, his widow, married again, her husband being a Mr. Ginder a native of Germany, a merchant on East King St., Lancaster City, for many years. Reuben, Jr., became an able business man and carried on the grocery store after the death of his stepfather. In 1874 he married Miss Adela Curtis, of Lancaster Co., Pa. She was born Dec. 19, 1854; died Sept. 11, 1901. To them were born two daughters: Mary, the eldest, born Aug. 4, 1887. She married Joseph Mercer, a lineal descendent of General Mercer of Revolutionary fame. Mr. Mercer is at the present time occupied as a Bank clerk in the city of Lancaster, Pa.

Della, the youngest daughter of Reuben and Adela Curtis Shirk, was born in Lancaster, Pa., Sept. 5, 1893, is quite an accomplished young lady. Reuben, the father, after the death of his wife, has remained single and is clerking in a hardware store on East King St., Lancaster. Their address being 351 E. King St.

The mother of Reuben Shirk, Mrs. Mary Ginder, at the advanced age of 89 years is living alone in Lancaster, is yet quite able to do her work of keeping house. Della Shirk, the granddaughter, living close, and is daily visiting and caring for her

when her grandmother is not able to care for herself.

Levi Shirk, the first born of the second marriage, born near Schoeneck, Pa., Sept. 8, 1829. He was married Oct. 3, 1858, to Sarah Hagey, a daughter of Henry and S. (Brubaker) Hagey. His wife was also born near Schoeneck, Pa., Feb. 6, 1837. During the early years of his married life he engaged in farming, later in buying and selling horses. Served as School Director, as a Director of Lincoln National Bank, and as a Director of the Northern Mutul Insurance Company, serving in the latter office for many years. Levi Shirk was an honored and highly esteemed citizen of the community in which he resided. He died April 10, 1907. Mrs. Shirk died Nov. 12, 1892. Both buried at Springville Cemetery, Lancaster Co., Pa.

To Levi and Sarah Shirk were born two children: Martin, and Lizzie who died at Lincoln, Pa., April 1, 1880, aged 15 years, four months and 15 days.

Martin H. Shirk, son of Levi and Sarah Shirk, born Feb. 1, 1863, and received his education in the public schools of Lincoln, Pa., at the age of 24 years; married Miss Anna Landes, Sept. 13, 1887. Anna, his wife, a daughter of Jacob and Sarah (Frey) Lnndes was born Oct. 28, 1866. About the year 1895, they moved to near Richmond, Va., on a farm of over 500 acres, where they resided and improved this large farm; when in 1906, he sold

the farm and moved to Lincoln, Lancaster Co., Pa., where he now resides, amid the scenes of his boyhood days, in a large mansion that he has erected for their convenience and comfort, in which they will now enjoy what they have accumulated by energy, ability and perseverance.

To their union were born four children, three daughters and one son. Evelyn, born in Lincoln, Pa., June 18, 1888, receiving her education at Glendale Schools, and later finished her course of fitting herself to teach at the Farmville, Va., female Seminary. She taught afterwards in both Va. and Pa. schools. April 27, 1910, she united in marriage with Everett Rollins Carey, a son of Mr. and Mrs. William Carey, of Saulsbury, Md., and is employed by the C. & O. R. R. as operator, stationed at Denbigh, Va. To this union is born one son, Martin William Carey, Dec. 11, 1911, and one daughter, Annie Evelyn.

Valerie Shirk, daughter of M. H. and Annie Shirk, born in Lincoln, Pa., Aug. 23, 1890, is an accomplished stenographer, now employed at the office of New Port News Ship Yard, Va.

Ernestine Shirk, daughter of M. H. and Annie Shirk, born Feb. 21, 1892, is now working at dress-making, Philadelphia, Pa.

Kenelm Shirk, son of M. H. and Annie Shirk, born Aug. 11, 1894 and is a student at Washington & Lee University, Va.

Daniel Y. Shirk, second son of Samuel and Mary Yocom Shirk, born near Schoeneck, Pa., Sept. 23, 1830. Learned saddle an harness trade in Lancaster, traveled and worked at his trade in many places over the United States, when in Philadelphia. enlisted in the U.S. Navy for a term of four years; after his discharge the civil war commenced, he again enlisted in the U.S. Army and served during the war. In 1868 he united in marriage with Matilda Lesh Barnett, she being a war widow (had been married to David Barnett, who died while serving his country in the army). Matilda, his wife was born in Nimashillin Twp., Stark Co., Ohio, Angust 21, 1844; died Dec. 23, 1907, aged 63 years. Daniel died March 11, 1911. Both are buried in Oak Lawn Cemetery, North Manchester, Ind. Many years he was a worthy and consistent member of the Church of the Brethren. His wife being a member of the Progressive Brethren. To them were born four girls: Mrs. Emma Angell of Blue Island, Ill.; Mrs. Lucy Reed of California; Mrs. Alice Myers of Grand Rapids, Mich., and Mrs. Ella Wagner, of Mishawaka, Ind.

Henry Y. Shirk, third son of Samuel and Mary Yocom Shirk, born near Reading, Berks Co., Pa., May 9, 1832. In the year 1835 he came to Lancaster Co., with his parents and in 1839 to Mount Joy, Lancaster Co., Pa., where he attended the common schools of that date during the winter only until he reached the age of 15 years, when he

was apprenticed to the printing trade at Lancaster, Pa., at the office of the "Volksfreund & Beobachter", a German paper of some distinction in those days. It not being of his own choice, he left the place and in 1851 traveled across the Allegheney Mountains on foot nearly all the way to Louisville, Stark Co., Ohio, where he remained on a farm, working for 50c day; in 1854, went back to Lancaster Co., and taught school; after the close of the term, again went to Ohio. When the Civil War commenced he volunteered for service under Capt. Manderson, Com. A. 19, Ohio. At the expiration of his term of service, married Miss Margaret Trump of Stark Co., Ohio, daughter of Michael and Salome (Simmons) Trump. Margaret Trump was born August 26, 1842. To this union were born six children, three sons and three daughters: Elmira, born in Plain Twp., Stark Co., Ohio, May 23, 1862; died June 6, 1863, aged one year and 14 days.

Clara Celandine, born near South Bend, Ind., Jan. 9, 1864. Byron Spencer, born in Plain Twp., Stark Co., Ohio, March 11, 1865. Flora Frances, born in Nimashillin Twp., Stark Co., Ohio, Feb. 18, 1867; Raymond Lee, born June 3, 1871, La Paz, Ind.; Henry Trump born Nov. 10, 1878, near La-Paz, Ind.

Henry Y. Shirk moved from Stark Co., Ohio to Marshall Co. Ind., 1869, bought of the David Cutler heirs, 160 acre farm, where now LaPaz is built, which was laid out after the B. & O. R. R. was built

in 1873; later he bought the Grover & Sykes farm one-half mile south of LaPaz, where he had lived 23 years on a farm containing 196 acres, where he raised and educated his children. He also for a number of years bought and shipped horses to the eastern market. In 1892 started the first hardware store in LaPaz and continued in business until 1902, when he sold to his son, Henry, and has lived a retired life in LaPaz since then (1914).

Clara Shirk, daughter of H. Y. and Margaret Shirk taught school five terms, when on Nov. 2, 1884, she united in marriage to Henry L. Jarrel, also being teacher, he was born Nov. 8, 1853.

To this union were born two children, a boy dying in infancy and Mamie C. born in Tyner, Ind., Oct. 23, 1886. Married April 29, 1906 to John I. Stoneburger, and they are the parents of one son, Henry E. born July 26, 1809. They are living on their farm one-half mile from Tyner, Ind.

Clara Shirk Jarrel died April 24, 1905, aged 40 years.

Byron Spencer Shirk, son of H. Y. and Margaret Shirk, married Miss Bettie Lineback, daughter of George and Mallie (Higby) Lineback, of LaPaz, Ind., on Sept. 9, 1888. To this union was born an only son, Donald Raymond, 1890.

He is taking a practical electrical course of study in the state of Idaho, to finish at Cornell University, N. Y. Byron S. Shirk is employed by the Kirk Mfg. Co., and has been with them many years. His residence is 115 E. Oak St., Chicago, Ill.

Flora F. Shirk, daughter of H. Y. and Margaret Shirk, married Frank O. McCormick, of LaPaz, Ind. in 1885. To this union were born four sons: Floyd, Henry, Charles and Winfield Leroy. The three first died while young. W. L., born March, 1892, is at the present time engaged in the American Express Company Office at Laramie, Wyoming.

Frank O. McCormick was killed by an accident in a Copper Mine, Wyo. 1907. His widow, Flora Shirk McCormick again married. Her second marriage being with Mr. Albert Hunter, a native of Wyoming. They are now residing on a farm owned by her father in North Twp., Marshall Co., Ind.

Raymond Lee Shirk, son of H. Y. and Margaret Shirk has been employed by the Adams Express Co. for many years. In 1903 he quit the Adams and commenced with the American Express Co., and now is Assistant General Agent in the Chicago office. On June 18, 1901, he married Lettie Funk Kaufman, she being born Dec. 4, 1875.

They have one daughter, Hermona, born June 1, 1895, by a former marriage with Doctor Kaufman.

Henry Trump Shirk, son of H. Y. and Margaret Shirk, married Miss Nellie M. Broadhurst,

March 23, 1900, a daughter of Robert and Sadie (Buckle) Broadhurst of South Bend, Ind. Henry T. is the proprietor and successor of the H. Y. Shirk Hardware Store, which his father founded and established in 1892 in LaPaz, Ind.

Henry T. has proven himself a successful and efficient merchant. To their union were born two children: Rowie, born April 7, 1901; died, aged three months old.

Robert Henry, son of Henry T. and Nellie M. Shirk was born Aug. 25, 1904. He is very bright and intelligent in his studies, being in the fourth grade in school, with prospects of a promotion soon.

Margaret, the wife of Henry Y. Shirk, after a lingering sickness of several months, died Sept. 4, 1914, aged 72 years, 9 days. Buried at the Fair Cemetery, St. Joseph Co., Ind.

Eliza Shirk, daughter of Samuel and Mary Shirk, was born in Berne Twp., Berks Co., Pa. With her parents came to Lancaster Co., Pa., when two years of age, where she married in 1853, Gerhard Leed, a native of Lancaster Co., Pa., born Jan. 16, 1832. To this union were born: Amelia, in Clay Twp., Lancaster Co., Pa., Oct. 2, 1854; Mary Ellen in Warwick Twp., Lancaster Co., Pa., March 22, 1856; died in infancy; Amatius S. Leed in Warwick, Twp., Lancaster Co., Pa., Dec. 3, 1859.; Clara in Lake Twp., Stark Co., Ohio, Dec. 31, 1865; Wilson in Plain Twp., Stark Co., Ohio, Oct. 11, 1867;

Myron, in Plain Twp., Stark Co., Ohio, July 8, 1870; died in Bremen, Ind., 1880, aged nine years; Frances in New Berlin, Ohio, June 10, 1876.

Mr. and Mrs. Leed moved to Stark Co., Ohio in 1860, where he was engaged in the hotel business in Greentown and New Berlin, Ohio. During the Civil War, 1862, he was drafted, serving his time until the expiration of his term of service.

In 1877, they sold their hotel in New Berlin, Stark Co., Ohio, and bought a farm of 100 acres near LaPaz, Ind., where they took up their abode and continued farming several years when they again took up the hotel business at Bremen, Ind., afterwards in Lakeville and LaPaz, Ind. Later moved on a farm they purchased near Teegarden Ind., farming several years when they bought property in Bremen, where Mr. Leed died in 1906, aged 74 years.

Frances Bach married Mr. Slocum, they being the parents of two children: Forest, born Sept. 11, 1908; Byron, April 24, 1911.

Amatius S. Leed, the second child, married Lizzie Farver, who was born Feb. 9, 1860. Mr.

Leed died April 3, 1903, aged 43 years, established the first livery barn in LaPaz. Their children were born as follows: Charles F., one dying in infancy; Aline, born Sept. 30, 1888, married Benj. H. Davenport, are residing in Montana; Cleo, born July 22, 1891, living with her mother in LaPaz, Ind., employed in the Central Telephone, LaPaz; Clara Leed was born in Lake Twp., Stark Co., Ohio, March 28, 1862; married William Kuntz of Bremen, Ind., a barber by occupation. To them were born two daughters: Mrs. Dan Flynn and Mrs. Earl Wilson. Amanda Leed was born in New Berlin, Ohio, Dec. 31, 1865; married Delbert Moore of Lakeville, Ind., a son of Dr. Robert and Mrs. Moore. To this union were born seven children: Judson, Elzora, Robert, Norman, Lulu, Marie and Leone.

Judson Moore married Miss Grace Vorhies of Marshall Co., Ind.; Elzora Moore married Thomas Pope, of South Bend, Ind.; Norman married Miss Apfel of California; Lulu married Ear! Riddle of Lakeville, Ind.

Wilson Leed was born in New Berlin, Stark Co., Ohio, Oct. 11, 1867; never married and is the proprietor of a restaurant in LaPaz, Ind.; Myron Leed was born in New Berlin Stark Co., Ohio, July 8, 1870; died in Bremen, aged nine years. Frances Leed was born in New Berlin, Stark County, Ohio, Oct. 24, 1873; married Charles M. Shock, a native of Bremen, Ind. Mr. Shock has been employed by Lowenstein of Bremen, Ind.,

for a number of years, proving himself a very efficient salesman for that firm. To this union was born an only child, a daughter: Una Shock, born in Bremen, Ind., Feb. 13, 1901. Charles M. Shock, the father was born May 15, 1872.

Charles O. Leed was born in New Berlin, Ohio, June 10, 1876. Was brought by his parents to Marshall Co., Ind. 1877. Married to Laura Mummy, 1905. They are the parents of three children: Hilda, born Oct. 12, 1905 and Victor, and one dying in infancy. Charles O. Leed is the proprietor of the LaPaz meat market, and has proven himself a man of good business qualifications, conducting the finest market LaPaz ever had.

Rudolph Y. Shirk, son of Samuel and Mary Yocum Shirk, born in Berks Co., Pa., March 2, 1835. Came when a child with his parents to Lancaster Co., Pa. When at the age of 14 years, through a severe sickness became a cripple for life. Though a cripple he was very industrious, learning the cigar making trade and working in that line of business off and on during his life. In 1877, he went to Marshall Co., Ind., and in the autumn of 1879, married Miss Amelia Rupert of Lakeville, Ind. To this union were born three daughters: Agnes, born in St. Joseph Co., Ind., 1880; Mary Edna, born in Marshall Co., Ind., 1882; Anna Elizabeth, born in Marshall Co., Ind., 1887. Rudolph, their father, died March 27, 1903; buried at Fair Cemetery, St. Joseph Co., Ind. Amelia Rupert, wife of R. Y. Shirk, died 1891.

The girls were of studious habits and acquired a fair education and all have good positions in Los Angeles, California.

Catherine A. Shirk, the youngest child of Samuel and Mary (Yocom) Shirk. Born near Mount Joy, Lancaster Co., Pa. Feb. 27, 1840, united in marriage to Moses Hower of New Berlin, Ohio. Mr. Hower was born Feb. 19, 1837, was a carpenter by trade, and at the commencement of the Civil war in 1861, he enlisted for service in the 19th Ohio all during the war, taking part in the Battle of Pittsburg landing, and Stone River, where he was severely wounded. At the close of the war he again took up his abode amid the scenes of his childhood days, at New Berlin, Ohio, where as stated above he married Miss Shirk and turned his attention to his trade and by diligence, hard work and frugality saved enough to acquire a home and later sold out and moved to California, only remaining in the land of flowers and sunshie two years, when they moved back, locating this time at North Manchester, Ind. Becoming dissatisfied with the "Hoosier State" sold out again and moved back to his old home place in New Berlin, Ohio, where they erected a fine house to suit their convenience, and are living very nicely and comfortably in their declining years of life. They have no children of their own, but in goodness and kindness of heart, they have been benevolent enough to take

a child to raise, a foster-daughter, which took the name of Mamie Hower, she being adopted.

Mamie grew up to be a very comely and intelligent woman and united in marriage with Charles Meade, a harness-maker by trade, and is following this vocation in Akron Ohio, where he is conducting for himself an extensive business.

Mr. and Mrs. Hower have both been members of the Brethren Church for many years, and are leading an exemplary Christian life.

The original families of the Shirks were all of the Mennonite church and still a great number of them are of that denomination and others of the plain people, who wear the plain garb of those churches, which are opposed to pride considering it to be the root of all evil.

Catherine Shirk, the second daughter and fifth child of Ulrich (III.) and Mariah Eberley Shirk was born at the original Shirk homestead near Schoeneck, Lancaster Co., Pa., Nov. 28, 1787; married Daniel Merkel Dec. 26, 1811. He was born Dec. 26, 1779; died May 8, 1861, aged 81 years. Catherine, his wife, died Nov. 2, 1874, aged 87 years. To their marriage were born five children. Samuel, their only son was born Sept. 7, 1812; married Mary Ann Miller of Sinking Springs, Berks Co., Pa., on Oct. 29, 1837. Mary Ann, his wife, was born June 11, 1814, and died July 8, 1895, aged 81 years. Samuel died Oct. 13, 1854, aged 42 years.

To their union were born six children, five sons and one daughter: John, born Feb. 20, 1839, died June 1857, aged 18 years.

Catherine Ann was born June 8, 1841; married Martin W. Kurtz on Jan. 27, 1863. To this union were born six children: Levi, dying in infancy; Howard, married to Clara Orth, residing in Denver Colorado; Stella, married George Stauffer, residing in Milwaukee, Wis.; Bertha married Charles Lapp, living near Davis, Ill.; Martin married Elsie Long, residing in Davis, Ill; Lillie is living with her parents, Davis, Ill.

Daniel S. Merkel, born May 3, 1844; married Sybilla Yarger. She died 1893, they were the parents of one daughter, Mary.

Henry G. Merkel was born Oct, 29, 1846. Married Mary Glasser. To them were born two sons: Orton and William.

Levi Merkel was born Aug. 22, 1850. Married Mary Hill. She died 1899, they being the parent of six sons and one daughter, one son dying at the age of 29 years, unmarried.

Samuel Merkel was born Jan. 19, 1853; married Elmira Molter; they are the parents of five children.

Mary (or Polly) Merkel, born Jan. 20, 1814. Married John B. Smith of Womelsdorf, Berks Co., Pa. To them was born Frances, who married Mr. Taylor of Womelsdorf, Pa. Sabina Merkel, born Dec. 11, 1815. Married Henry Eberly; they are the parents of Mrs. John Wissler and Sabina Grohof Schaefferstown, being their daughter.

Sarah Merkel was born in Ephrata Twp., Lancaster Co., Pa., 1881: died at Denver, Pa., 1906, aged 88 years. She being married to Daniel Fry, who preceded her to the Great Beyond 46 years. Three sons and three daughters were born to them, of whom only three are living: Sabina C. the wife of A. J. Ream of Denver, Pa., with whom the widow had been living since 1876; Sarah, wife of George B. Sensenig of Lancaster and Henry M. Fry of Reading, Pa.

Otilla, wife of Levi P. Becker is an only grand-daughter of Mrs. Fry.

Mrs. Fry was a member of the Baptist Brethren Church, for many years. Her remains are resting at the Denver cemetery.

Elizabeth Merkel, also a daughter of Daniel and Catherine (Shirk) Merkel, was born June 8, 1822; married John Fry of Frysville, Lancaster Co., Pa. They were the parents of Mrs. John Seldomridge of Ephrata, Pa., Jacob M. Fry of Hahnstown, Pa., and John M. Fry, Esq., now deceased, a practising lawyer in Lancaster, Pa.

Note: The Catharine Merkel data is not com-

plete, which the author of this book desired very much, but did not get any response of those he had written to, the meagre personal knowledge he has of the family does not give the desired justice to this branch of the Catherine (Shirk) Merkel descendents.

Lizzie Shirk, daughter of Ulrich and Maria Eberley Shirk, was born in West Cocalico Twp., Lancaster Co., Pa., about the year 1790 and died about the year 1871, aged 82 years. She was twice married, her first husband being Jacob Keller, they were the parents of one son and one daughter, both dying young. Jacob Keller, her first husband, died in about the year 1840 or 1841. In a few years after her husband's death, she married again to George Keller, a widower, and brother to her first husband. Both were model men in every respect, being members of the old order of the Bretheren Church.

Ulrich Shirk (IV.) son of Ulrich and Maria Shirk, born on the old Ulrich Shirk farm, near Schoeneck, Lancaster Co., Pa., 1792, and died 1858, aged 66 years. He was a born mute, never married, had his home provided, (by the will of his father), with his youngest brother, Peter Shirk, who became the owner of the original Shirk homestead by inheritance from his father, Ulrich (III.)

Jacob Shirk, a son of Ulrich and Maria Eberley Shirk, was born and reared in West Cocalico Twp., Lancaster Co., Pa., born 1796; married Miss Catherine Erb. To this union were born eight children: Daniel E., Benjamin E., Mary, Joseph E., Jacob, Levi (died young), Elias, and David E. Jacob and Catherine, after marriage, bought a fine farm in Clay Twp., Lancaster Co., where all their children were born. Catherine, their mother, died Sept. 1842, aged 43 years. Jacob, the father of this family, sold his farm and bought a farm adjoining the corporation of Lancaster City, and about the same time again married, a Mrs. Eliza Markley, a widow in Lancaster City. To them were born two children: Henry and Lizzie; they both died young, and on Dec. 5, 1871, Jacob Shirk died leaving a large estate of valuable property, his second wife dying a few years later.

Dr. Daniel E. Shirk, Jacob and Catherine's first child, born Oct. 12, 1820, was reared on his father's farm in Clay Twp., Lancaster Co., Pa., receiving a limited education in his youth, but by diligent study acquired a fair knowledge of different languages: Greek, Latin, French and German; studied medicine with the celebrated Doctor George B. Kerfoot, of Lancaster, Pa. Commenced practising medicine at the age of 22 years in the village, now Lincoln, Pa. In 1842, he united in marriage with Amelia Wilson, of Reamstown, Lancaster Co., Pa. Eight children were born to them: Hiester, Wilson, Oliver, Daniel, Jacob, Amelia, Catherine and Lizzie.

Dr. Shirk had lived in Carroll County, Iowa, some 18 years, and from there came to Mountain

Grove, Mo., where he died July 5, 1900. His wife preceded her husband in death about three months. In religion, he was a German Baptist, he and his wife having been members of that denomination for many years.

Benjamin E. A grandson, Walter Shirk, of Madison, Wisconsin, who had been reared by Dr. Shirk. Jefferson Shirk his father, being the oldest son, died many years ago.

Mary Shirk, Jacob and Catherine's only daughter, was born and reared on her father's farm in Clay Twp., Lancaster Co., Pa., born Feb. 1, 1823. Married Emanuel Buch who was born May 27, 1814. After marriage, they took up their residence

on a farm they bought near Lincoln, Lancaster Co., Pa., where to them were born the following named children: Jacob S., April 21, 1843; Mary Ann, June 15, 1846; died Jan. 3, 1871, aged 25 years. Being of a studious nature, acquired a good business education, and engaged in the hardware trade for four years in the city of Lancaster Pa. In the spring of 1850, went to Jackson Co., Iowa, where he bought several hundred acres of good farming land and engaged in farming and stockraising. In Oct. 1856, he united in marriage with Miss Sarah Gockley, who was born at Williamstown, Dauphin Co., Pa., March 31, 1836. To them were born three girls, Mary A., Catherine and Elizabeth.

Mr. Shirk has by energy, ability and perseverence accumulated a handsome estate of mostly farm property, of the best quality. God has favored him with a long life to enjoy the fruits of his labor He died July 25, 1912, aged 84 years. Mrs. Shirk preceded him in death seven years, aged 69 years.

Jacob E. Shirk, the fourth son and fifth child of Jacob and Catherine (Erb) Shirk, was born May 25, 1830; died July 16, 1895. Mrs. Shirk was born Sept. 16, 1820; died May 10, 1909. In his young days enlisted in the U.S. Navy in 1852, cruising with the expedition sent to Japan by the United States government to obtain a treaty in which two ports were opened to commerce in 1854, which was conducted by Commodore Perry. He had also been on the briny waters of the ocean on a whaling expedition. Later in life, went to Blue Earth County, Minnesota, where he married his wife and settled down to farm life, and acquired a fine farm, where he spent the balance of his life in farming and stock raising. To their marriage were born twelve children and all are living (1913); Laura (Shirk) Reed, Jefferson Shirk, farmer and stockraiser; (Shirk) Chaffee, Nora (Shirk) Foster: Simon Shirk, a farmer; Arminta (Shirk) Scott; Leah (Shirk) Ackerman; Jacob Shirk, a farmer; David Shirk, a farmer; Theodore Shirk, a farmer; Mae Shirk, a stenographer; George Shirk, a traveling man. Elias E. Shirk, the sixth son and seventh child of Jacob and Catherine (Erb) Shirk, was born in Clay Twp., Lancaster Co., Pa. His mother died when he was quite young. His sister, Mary Buch,

wife of Emanuel Buch, gave him a home after his mother's death, where he remained until his maturity, when he took up his abode in the Hawkeye State, there he also took his companion. To their union were born eleven children; two died in infancy. To them were born Theresa; she married Howard Miller, druggist of Monmouth, Ia. Samuel B. died at the age of 54 years. Jacob B. married Cora Shieb and are living at Monmouth, Ia. They are the parents of ten children: Elizabeth B. married Francis J. Juel. Shirk was a well read and public spirited, and highly respected man, by all who knew him, arriving at the ripe old age of 78 years when he departed this life in November 1913 at his home in Monmouth, Ia., where also his offspring are yet remaining except Mary Jane (Mrs. Jacob Fasnacht), who is residing in Philadelphia, Pa.

David E. Shirk, seventh son and eighth child of Jacob and Catherine (Erb) Shirk, was born in Clay Twp. Lancaster Co., Pa., lived with his father in Lancaster, working at brick making on his father's farm, later entered into the cold storage business of butter, eggs, etc. In about 1860 he married Miss Susan Holsworth. To their union were born two daughters: Mary, wife of William Hawkins and Jane, the wife of George Snyder. In 1869 David, with his family, took up their abode at Sac City, Iowa, where he died April 24, 1903, his wife preceding him in death a week prior.

Jacob Shirk, second son of Michael and Barbara Flickinger Shirk, was born Dec. 4, 1787. Died Aug. 11, 1862, aged 75 years. He was married to Nancy Hauck, who was born Aug. 8, 1783; died April 4, 1871, aged 79 years. They were the parents of 13 children, all arriving at the age of maturity. Harry Shirk, born May 25, 1812; died Dec. 13, 1878. He was married to Polly Bucher. They were the parents of Henry Shirk of Lebanon Co., Pa. Henry, being married, and the father of Ira Shirk, who died at the age of 24 years, 1913.

George Shirk, the second in line of birth was born Nov. 3, 1813; died March 1, 1839, never married.

Rudolph Shirk, born at Shirk Crossroad, West Cocailco Twp., Lancaster Co., Pa., Sept. 16, 1818; died Dec. 2, 1895, was married to Barbara Reinhold, who was born March 25, 1825; died Sept. 9, 1884 Ten children were born to their marriage. Maria, wife of John Brubaker, was born Aug. 6, 1845; died

June 8, 1874. Two sons were born, Abraham and Jacob, both survive.

Ramanda, wife of Obed Dombach, was born Nov. 23, 1846; died Jan. 22, 1901, of which two children survive, Evan and Annie.

Michael Shirk, son of Michael and Barbara Flickinger Shirk, was born in Lancaster Co., Pa., June 21, 1792; united in marriage to Barbara Allabaugh in 1814. She was born July 3, 1794. To this union were born: Benjamin, July 23, 1815; Michael, Aug. 25, 1818; Daniel, Aug. 9, 1821; Catherine, Oct. 27, 1823; John, Aug. 10, 1825; Joel, Dec. 6, 1827; Elizabeth, Nov. 25, 1829. John Shirk, the fifth child, and fourth son of Michael and Barbara Allabaugh Shirk, was born in Lancaster Co., Pa., Aug. 10, 1825. He, with his parents, came to Coshocton Co., Ohio, when quite young, where he attained his manhood amidst the scenery of a frontier life before any railroads extended farther west than Harrisburg, Pa. When stock of all kinds raised in the west had to be driven on foot to the Eastern Markets, Coshocton Co., Ohio, at that time and a long time after, had the reputation of breeding and transporting some of the finest cattle brought to the Eastern Markets. John Shirk on Nov. 15, 1848, united in marriage to Harriet Josephine Powell, of Adams Twp., Coshocton Co., Ohio. His wife was born Aug. 21, 1825. To this union were born seven children, four sons and three daughters: Washington Daniel, in Cochocton Co., Ohio, Nov. 7, 1849; Arthur Freeman, same place, Oct. 21, 1825; Nettie Jane Day, March 14, 1855; Catherine Louisa, April 1, 1860; died May 20, 1863; Lawrence O., Dec. 31, 1861; Alta Caroline, Jan. 26, 1866; Milton Grant, April 5, 1868. The wife and mother died in Iowa, Jan. 30, 1886. John married his second wife in Ohio, Dec. 5, 1892. His second wife died in Ohio, July 24, 1896; no children to second marriage. John Shirk is living with his son, Milton Grant Shirk, Shirkville, South Dakota. him belongs the distinction of being the oldest Shirk living, of the generation compiled in this book, being at present in his 90th year. After his demise, that mantle is believed to drop on the author of this narrative (should he survive his cousin John). He being in his 83rd year.

Mrs. Joel Shirk died in Ill., July 2, 1899. Joel Shirk died in New York, Aug. 20, 1903, aged 76 years.

Came, when a child, with her parents, to Coshocton Co., Ohio, where on Aug. 15, 1849, she united in marriage to James Williams, a native of Ohio. John R. Shirk, second child and first son in line of birth, to Joel and Elizabeth Shirk, was born in Lancaster Co., Pa., Jan. 26, 1834, where he grew to manhood, receiving an ample education in common schools of those days, to start in as clerk in a

general store in Schoeneck, where he was employed a number of years, when he married Miss Annie Lizzie Fry, a daughter of Mr. and Mrs. Curtis Fry. Mrs. Shirk was also born and reared in Lancaster Co., Pa. Her birth was on Dec. 19, 1835; died March 28, 1910. In April 1865, they left Schoeneck, Pa., and moved to Osborn, Ohio, where they resided four years when they moved to near Albion, Noble Co., Ind., and in 1886, took up their abode near South Bend, on a large farm, owned by Alexis Coquillard, where they later moved into the city, engaging in the grocery business. After the death of his wife, made his home with his son William, at Rose Lawn, where the first Shirk reunion was held Aug. 3, 1913, John R. Shirk, having instituted the event, and is to be continued annually on the first Sunday in Aug. In 1914, was held Aug. 2, at Island Park, South Bend, Ind. Sibley's hardware store, South Bend, until Mr. Slbley's death, when he with his brother William engaged in the pursuit of farming, and are at present located on a farm containing 160 acres, eight miles south-

east of Mishawaka, Ind., their father living with them.

Elmer E. Shirk, second son in line of birth of John R. and Lizzie Shirk's family, married Metea Gillespie of Albion, Ind. Their children are: Edwin Earl, deceased; Grace Lingard; Russell and Lewis.

Annie Shirk married David Cripe, a farmer. To their union were born Ruth D.; Carl D., and Paul. Mr. Cripe, being the owner of a fine little farm at Rose Lawn, Ind., where they reside.

Michael Shirk, the father of this family, was killed in an elevator accident at Studebakers, July 17, 1905. The widow survives at the age of 79 years (1914).

Henry R. Shirk, the third son and fourth child of Joel and Elizabeth Reinhold Shirk, born in Lancaster Co. Pa., Feb. 20, 1842, came with his parents to Indiana, 1869. His first wife bore the maiden name of Catherine Shaffer. To them was born one child, Annie. She married Mr. Leets, a farmer by occupation, living at Hascalls, Ind. They are the parents of five children: Lillian, Bertha, Louis, Howard and Ruth.

Henry, after the death of his first wife, married Fannie Zimmerman. They were the parents of three sons: Joel B., born 1881; married Katie Loshbaugh, deceased. They were the parents of Henry, a fireman at South Bend, Ind., and Mary Shirk.

Harry R. Shirk, born March 20 1882 is a clerk in Cleveland, Ohio.

John Mohler Shirk, born Nov. 28, 1884; married Lou Burger, daughter of William and Annie Clayton Burger, of South Bend, Ind. To this union were born Forest and Merlin. John M. is employed as foreman Studebaker Corp., and resides at 1510 Witwer Ave.

Henry R. Shirk, the father of the above named family, being a good mechanic in the line of manufacturing coaches and buggies moved from Albion, Noble Co., Ind., Oct. 1882, to South Bend, Ind., where he departed this life 1911.

Sarah R. Shirk, a daughter of Joel and Elizabeth Reinhold Shirk, was born in Lancaster Co., Pa., April 11, 1847; came to Noble Co., Ind., with her parents in 1869, where she united in marriage to William W. Carey, he being born in Jefferson Twp., Noble Co., Ind. Mr. Carey was reared on a farm, when later he learned the carpenter trade and has continued this vocation since. At the age of 23 years Sept. 11, 1870, Mr. Carey married as stated above Miss Sarah Shirk. This family since marriage, have taken up their abode in Albion, the county seat of Noble Co., Ind., where they are nicely and happily located amidst the scenes of their young days; they have no children to make this life a happy one, nor mar this life with grief and sorrows.

Ruben R. Shirk, the youngest son of Joel and Elizabeth Reinhold Shirk, born in Lancaster Co., Pa., Dec. 8, 1853, arriving with his parents near Albion, Ind., in 1869 married Miss Ella Black. On Nov. 1902, moved to South Bend, Ind., and is now residing on a handsome small farm wihin one-half mile of the city limits on what is called the Turkey Creek road. The family of their children are: Joel

P. Shirk, born Dec. 17 1883 living in Chicago, employed as an office clerk; Charles C., born Nov. 30, 1889; Lutie E., born Sept. 26 1891; R. Robert, born Jan. 7, 1894; Shirley C., born Dec. 6, 1895; Dallas A., born March 5, 1898; the last named five children are all living with their parents at home.

These are the Descendants of the Shirk Brothers Whom we cannot Trace, or Connect with the Original Ancestors

Elbert Hamilton Shirk, of Peru, Ind., was born in Franklin Co., Ind., Feb. 14, 1818. He was the second son of Samuel and Elizabeth (Stout) Shirk, natives of Ohio and Kentucky respectively. He attended the public schools and remained on his father's farm until he rrived at the age of 21 years. He then studied two years in the Miama University at Oxford, Ohio. Taught the two succeeding years in the County Seminary at Rushville, Ind. In May, 1844, settled in Peru. There, for the next eleven years he was engaged as a merchant first in partnership with Mr. Harlan and afterwards alone. In 1855, engaged in dealing in Western lands, and has largely since operated in real estate. In 1857, established a private banking business. In 1860 he again engaged in mercantile persuits. In 1867, the firm of Kilgore and Shirk was formed and later it was changed to Kilgore, Shirk & Co., when they carried on a very extensive business. When the First National Bank, of Peru, was chartered in 1854, Mr. Shirk became its President. Mr. Shirk united in marriage June 18, 1845 to Mary Wright of Franklin Co., Ind. To this union were born four children: Milton, Elbert W., and Alice, wife of Mr. Edwards.

Samuel Alexander Shirk, born May 4, 1832 in Juniata Co., Pa. He was a son of Peter and Ann (Shellinger) Shirk, their residence is in Woodford Co., Ill.

Benjamin Palmer Shirk, born Sept. 15, 1864, residing in Bureau Co., Ill.

Revilo Hayes Shirk, born Dec. 25, 1876, resides in Minonk, Ill.

Sarah Elma Shirk married Shadrack Rickerson Barkly who was born Nov. 10, 1862. They reside in Hartford, Tulare Co., Cal. They have two children: Jesse M. born Jan. 23, 1886; Noretta Irene, born Sept. 27, 1888, in Hartford, Cal.

Jacob S. Shirk, general merchant Grantville, Pa. He was born in East Hanover Twp., Lebanon Co., Pa., June 30 1844, son of Michael and Elzabeth (Swope) Shirk. The father was born in the same twp., and county, and resided there until 1845, where he was also engaged in the mercantile business. He then removed his business to Dauphin Co., Pa., where he continued until death, which occurred Dec. 1857, Jacob S. his son, taking charge of he store after his father's death. Jacob S. married Emma Early. Their children are Marie; Ellen; died Nov. 18, 1889; Edward M.; Robert E., and Emma L. Mr. Shirk has served as auditor tax collector, and assessor in his county.

Adam B. Shirk, who was the owner in early times of the Caledonia grain elevator, and a pioneer of Kent Co., Mich. He was born in Waterloo Co., Province of Ontario, Canada, Feb. 21, 1826. His parents, Samuel and Magdalena (Brake) Shirk, natives of Franklin Co., Pa., were born April 19, 1792 his wife Aprl 3, 1786. Adam B. Shirk married Feb. 18, 1850 to Elizabeth Stauffer ,also a native of Canada.

Solomon S. Shirk was born in Walker, Juniata Co, Pa., July 31, 1843 is a son of James and Elizabeth Shirk.

David, his grandfather, was born in Lancaster Co., Pa., and removed to Juniata Co. Later to Bedford Co., where he died. He had been married o Mary Love, and they had ten children: James, John, David, Barbara, Joseph Samuel, Michael, Christopher, Levi and Henry.

Some of those Shirk's which cannot be connected in this Genealogy are undoubtedly descendents of the Swiss brothers who arrived here in this country in 1729, and first settled in Lancaster Co., Pa. They all invariably claim Lancaster Co. their first home in this country.

Henry Shirk of Portland Oregon Adam Shirk, Jr., of Oakland, Cal., and Henry Shirk of Pasadena, Cal., are all descendents of the Pa. Shirks.

Jacob Shirk was the son of a prominent farmer near Churchtown, Lancaster Co., Pa., who also serv-

ed as County Commissioner of Lancaster Co. He was a Federalist politically, and religiously was a member of the Reformed Church. He was born in 1764 and died in 1844, aged 80 years. We have not been able to get the name of this father, but he was the parent of five sons and two daughters of whom our subject Jacob was the youngest. The others were Amelia, Maggie Henry, William, David and Mathias.

Jacob learned the tanner trade, and for a number of years operated a tannery at Hahnstown, Lancaster Co. Later he moved to Earl Twp., and soon after to Churchtown, where he was born. Here he lived for several years, later taking up farming near Beartown. Later he was for a time a resident of Mt. Joy Pa., spending the last days of his life in Lancaster City, dying at the home of his son, H. S. Shirk at the age of 85 years. His wife was a Miss Hannah Waddel and to their union were born eight children as follows: Henry S.; Sarah, born April 24, 1829; Perina A., born March 8, 1831; Mary A., born March 28, 1833; Martha, born April 16, 1836; William A., born Oct. 3, 1839; two died in infancy, George and Jacob Hahn.

H. S. Shirk was born Feb. 20, 1826, in New Holland, Lancaster Co., Pa. He attended the common schools and those at Churchtown, until he was 15 years of age, the next two years clerking for merchants at various places and then went in business with a Mr. Masterson at Mt. Joy. Here he remain-

ed eight years, then going to Millersville engaging in the cigar business. Mr. Shirk then went to Lancaster and in partnership with his brother-in-law, J. G. Peters, bought the Conestoga cotton mills afterward erecting what is now known as the Stevens cotton mill. After operating this mill five years he bought out his brother-in-law and took into partnership his two sons, Jacob and Abram. Besides these two sons there were three daughters, Laura wife of John Martin, Alice wife of Samuel Bausman and Anna, who died when young. The mother's maiden name was Mary A. Peters. Mr. Shirk is a member of the Reformed Church, and lodge No. 43 Masonic order.

Sarah Shirk married Isaac Stirk of Lancaster, Pa. Pa.

Perina A. married Edward D. Robison of Churchown, Pa.

Mary A. married Abram Kulp of Mt. Joy, Pa.

Martha Shirk married Martin Stirk, who died, and she afterward marred Albert Bissell and are now living in Oregon, Ill.

William A. Shirk born near Churchtown, Pa., and lived at home until thirteen years old when he clerked in his brothers store at Mt. Joy, Pa. He afterwards clerked in a general store at Huntington, Pa., and the W. E. Foster dry goods store in Harrisburg, Pa. He left here at the age of 20, and went to Iowa and has been a resident of that state ever

since. In Sept. 1861, he enlisted as private for service in the Civil war and was discharged July 1865, as Capt. of Com. E. 13th Iowa Infantry. After the war he lived in Davenport, Ia., and was engaged in the meat business for about ten years. Afterward, turning his attention to farming. He sold his farm in 1900 and is now living retired at LeClaire, Ia. He has been twice married. His first wife being Elizabeth Martin who died in 1905. His second wife is Marie Elnora Armstrong. Mr. Shirk has three sons: Edward M.; Harry J., who resides in Canada, and William R., who is in he employ of the U. S. Mail Service and lives in Chicago, Ill. Mr. Shirk is now 75 years old, and is the only one of this history enjoying the title of Capt.
